Attention: All Families of loved ones in Valley Manor

On December 21, 2020, the Ontario Government announced the implementation of a **province-wide shutdown**, effective Saturday, December 26, 2020 at 12:01 a.m.

The province has been divided by Northern Ontario and Southern Ontario; **Renfrew County and District (RCD) is considered part of Southern Ontario**.

The shutdown will remain in effect until Saturday, January 23, 2021.

For Valley Manor, this shutdown affects our home and residents in the following ways:

- All family visits including Essential Caregiver visits will be cancelled.
- Foot care, Physiotherapy visits and other similar externally provided services will be cancelled. Virtual assessments will be provided as able.
- Hairdressing services will be cancelled.
- Activities will be limited to individual in-room visits.
- Window, telephone and virtual visits via Skype/Facebook will be offered **by appointment** through the Activities department by calling 613-756-2643 extension 225.

Please continue to do your part to protect our residents, staff and families as well as yourselves by:

- Staying at home if sick and monitoring for symptoms
- Practice physical distancing (2 meters)
- Wear a mask/face covering when physical distancing cannot be maintained
- Wash your hands
- Consider vaccination not only for COVID-19 but for Influenza as well (many symptoms of influenza are the same as COVID-19)

RE: Foot Care Provisioning/Services Charges—New Effective February 1, 2021

SFMH is dedicated to ensuring access to services especially for high risk individuals. We are very proud to be providing nursing lead podiatry services to clients at Valley Manor and in the communities of Barry's Bay and Killaloe. .

In response to an in-depth review and in order to continue to address the growing needs of our community we have made the decision to increase the per session cost for both new admissions (initial assessment and treatment) and for follow-up treatments. This will allow SFMH to sustain these services long term in response to growing volumes and needs.

The new/revised rates effective February 1, 2021 are \$45.00 for new clients and \$35.00 for subsequent/follow-up sessions.
